PREMIERES

DEADLY RECALL

Season Two Premieres Wednesday, April 15 at 10/9c

Some crime scenes are so dreadful that law enforcement want to forget them, but Detective Pat Postiglione operates differently; he wants to remember every single detail. DEADLY RECALL follows homicide Det. Pat Postiglione as he explores crime scenes with his photographic memory and laser sharp eye for spotting key evidence. For some, this might be haunting, but for Det. Postiglione, it's his life calling.

- **Air McNair premieres Wednesday, April 15 at 10/9c**
