**A DEADLY DOSE**

**Three-Hour Special Premieres Saturday, September 19 at 9/8c**

The death of Susan Winters, an attorney and mother of two living in Las Vegas, is ruled by authorities to be a suicide. But strange details of her demise, including her ingestion of both antifreeze and oxycodone, have convinced Susan's parents that this was murder - and that Susan's husband Brent is connected to it. What follows is a real-time investigation as high-powered Vegas attorney Tony Sgro digs into the seedy underbelly of this case, unearthing a web of surreptitious drug use, suspicious financial transactions, clandestine meetings with felons, questionable police work, and disturbing toxicology results that lead to an explosive conclusion.

**JOE EXOTIC: TIGERS, LIES, AND COVER-UP**

In a matter of months, Joe Exotic and his sworn enemy, Carole Baskin, have become household names. Their saga played out for the world to see, but what has happened since the cameras stopped rolling? ID's definitive sequel, JOE EXOTIC: TIGERS, LIES AND COVER-UP, examines the biggest question in true crime today – what happened to Carole Baskin's husband, Don Lewis? This three-hour special takes a new look at the evidence surrounding Lewis's mysterious disappearance, helmed by an exclusive jailhouse interviews from the biggest character in the world: Joe Exotic himself. Retired homicide investigator Jim Rathmann leads the investigation to discover the truth, revealing new theories uncovered by private investigators, reliving Lewis's final days and demeanor with those closest to him, and unpacking evidence uncovered by criminal and legal experts. Punctuated throughout are interviews with those in Joe's inner circle, including husband, Dillon Passage and members of "Team Tiger," a group working to free

Joe from jail. Beyond the controversial missing person investigation, this special also explores the criminal case against Joe Exotic, and all the factors that led him straight to prison. New evidence comes to light that begs the question: Was Joe Exotic the predator all along, or is he actually the prey?

JOE EXOTIC: BEFORE HE WAS KING examines the childhood traumas and dramatic events which shaped the mind of the man who called himself the “Tiger King.” This comprehensive, one-hour special delivers vital information to put the entire sordid story in context and uncovers dark secrets about Joe’s past. Using exclusive and never-before-seen interview footage of Joe Exotic, including personal photos and home movies, this special reveals the dark secrets that led to the colossal crash which has landed him in prison for decades. What sent Joe Exotic down the path of depravity, polygamy, live animal collecting and trading and ultimately, conspiracy to commit murder? With expert commentary from forensic psychologists and law enforcement experts as well as new interviews with his inner circle – including a prison interview from Joe’s second husband, Jeffrey Charles “JC” Hartpence – this special analyzes the evidence and presents a vivid portrait of his psychological descent into madness.

## **PREMIERES**

### **CHAOS IN COURT**

**New Series Premieres Wednesday, September 16 at 10/9c**

CHAOS IN COURT examines clips of dramatic, unexpected, and cathartic courtroom moments. Each episode brings the backstories of the crimes and legal proceedings to the forefront with insightful analysis from a diverse panel of experts including judges, defense attorneys, prosecutors, and criminal psychologists. Featured within each episode are interviews with defendants, family members, and others who witnessed the action to help bring dramatic courtroom moments to life, and the emotional realities of what happens when the ultimate stakes are on trial.

- ***Predators Among Us premieres Wednesday, September 16 at 10/9c***

This episode features clips from several tense courtroom scenes: Larry Nassar faces his young sexual assault victims and their parents in court; a sadistic murderer spits on his attorney and torments the mother of the two teenagers he killed; Brian Earl Taylor sings his defense to the judge; and a judge allows a prisoner to hold his baby for the first time during his court hearing.

- ***If I Can't Have You premieres Wednesday, September 23 at 10/9c***

This episode features clips from several tense courtroom scenes: After the death of her young child, a woman discovers her boyfriend's disturbing secrets; Dale Williams shoots down his girlfriend in cold blood; Stalker Jacob Larsen accuses the judge of being too cozy with his victim; Daniel Villegas claims he was coerced into confessing to a crime he didn't commit; and a judge takes the law into his own hands when defendants make a run for it.

## **THE KILLER BESIDE ME**

### **Season Three Premieres Thursday, September 17 at 10/9c**

THE KILLER BESIDE ME exposes the dark underbelly of workplace evil, where rivalry romance and the abuse of power culminates in murder. Harrowing 911 calls, stark crime scene photographs, shocking surveillance footage, and poignant interviews with loved ones plunge viewers into the epicenter of these crimes. By the end of each episode, viewers will be left with one question: how well do you really know your co-workers?

- **Danger Travels premieres Thursday, September 17 at 10/9c**  
A retail store employee's crush on manager Antoinette Venditti Bruce escalates into an obsession after he is fired for inappropriate behavior. When she is transferred out of state for work, the stalker tracks her down to carry out his twisted plans.
- **Hostage to Greed premieres Thursday, September 24 at 10/9c**  
The murder of legal secretary Gail Spencer in her Macon, Georgia home leaves police with few clues as to who would want her dead. Then, a co-worker's alibi falls apart, revealing a callous conspiracy of greed that shocks this southern town.

- **The Grudge premieres Monday, September 14 at 10/9c**  
With her good looks and sunny demeanor, doctor's assistant and part-time model Christine Kent attracts her fair share of admirers. But after one encounter ignites jealousy and obsession, Christine is blind-sided by the devastating consequences.
- **Do You Love Me? premieres Monday, September 21 at 10/9c**  
Jeanne Smith and her two daughters, Marie and Anna, make for a tight-knit family trio. But when Jeanne and Anna go looking for love in all the wrong places, it ends in heartbreak, lies, and murder.

## **ONGOING SERIES**

## **HOMICIDE CITY**

### **New Episodes Premiere Tuesdays at 9/8c**

HOMICIDE CITY takes a deep dive into the crimes that shook Philadelphia to its core. The series explores cases from a darker time that had police detectives banding together across the metropolitan landscape in a sequence of manhunts. From the mansions of the wealthy suburbs

to the rowhouse-lined streets of the inner city, each episode is told through the eyes of veteran homicide detectives, local beat reporters and the victims' families who lost so much.

- **Shattered Dreams premieres Tuesday, September 15 at 9/8c**  
A 17-year-old aspiring artist is found dead in an abandoned house. A devastated family worries the case will never be solved, but 13 years later a lucky break in DNA technology points detectives in the right direction.
- **The Thin Blue Line premieres Tuesday, September 22 at 9/8c**  
A skeleton is discovered on the edge of a high school football field during a game of catch. It takes a forensic sculptor, tireless detective work, and some luck to finally bring the mysterious killer to justice.

### **LIVING A NIGHTMARE**

#### **New Episodes Premiere Tuesdays at 10/9c**

Imagine facing a situation so tragic that one convinces themselves they must be adrift in a nightmare. However, the realization soon comes crashing down that this is no dream – it's murder. LIVING A NIGHTMARE tells the stories of real people who face the surreal horror of losing loved ones to vicious crimes. With every tick of the clock, detectives work to seek justice for the families, all while never forgetting the victims whose own dreams were so callously interrupted.

- **Deadly Message premieres Tuesday, September 15 at 10/9c**  
When 23-year-old Julian Williams can't be reached by phone, his family knows something must be terribly wrong and contacts police. They eventually track down a taxi driver who gave Julian a ride the night he disappeared. Apparently, Julian had gone there to visit a new love interest -- a young woman who had been texting him for days. However, as investigators look beneath the surface, they soon learn she isn't who she claims.
- **Karma Comes Late premieres Tuesday, September 22 at 10/9c**  
Factory workers discover a young woman's body abandoned in an alley. Police identify her as 27-year-old Sherri Majors, a recently divorced mother of three. Her parents point the finger of suspicion at a new boyfriend. He claims he last saw Sherri at a bar, where she angrily dumped him and stormed out into the night. Detectives must retrace her steps, knowing the last person she encountered would be her killer. It will take 15 years for the truth to come out.

### **CRIMES GONE VIRAL**

#### **New Episodes Premiere Wednesdays at 9/8c**

CRIMES GONE VIRAL explores the riveting stories behind shocking crimes caught on camera that gain viral fame on the internet. From business security cameras to home surveillance systems and cell phone cameras, someone is almost always watching. Gripping clips of kidnappings, break-ins, wild car chases, violent road rage incidents and other crimes rack up millions of views. But CRIMES GONE VIRAL goes beyond the jaw-dropping footage to tell the full story. This series features compelling interviews and behind-the-scenes information of some of the internet's most viral crime clips.

- **Snatched premieres Wednesday, September 16 at 9/8c**

Carlesha Freeland-Gaither, a 22-year-old nurse's aide, is walking home after a family gathering in Philadelphia when a man approaches asking for directions. But when she tries to shake his hand, he grabs her, violently dragging her down the street and forcing her into a car and in just 30 seconds, Carlesha is gone. In the midst of the awful attack, Carlesha somehow manages to strategize, leaving police vital clues that help them trace her kidnapper. And in Georgia, 21-year-old college student Jaila Gladden goes to the pharmacy late one night to get cold medicine and never comes back. Her boyfriend wakes up to a series of terrifying texts, like "kidnapped," "knife," and "scared." But just like Carlesha, Jaila bravely outsmarts her kidnapper, giving investigators clues that help them figure out where she's been taken.

- ***Bold Moves premieres Wednesday, September 16 at 9:30/8:30c***

A masked gunman attempts a brazen midday holdup of a liquor store in Tulsa, Oklahoma. But the mother and daughter who run this family business fight back, determined to protect each other. Their brave actions stun investigators and leave everyone who watches the video in awe. Then, a thief picks the wrong target in Mid City, New Orleans. When he tries to steal a phone, the owner of the martial arts studio immediately jumps into action, giving him a harsh lesson in self-defense that earns her wide praise.

- ***Grab and Go premieres Wednesday, September 23 at 9/8c***

Four cousins are enjoying a night out on the town in Miami, celebrating a 21st birthday. But a stop for gas on the way home turns into a fight for their lives when a robber tries to hold them up at gunpoint. An all-out brawl ensues with a frightening struggle for the gun caught on camera. And then, in Albuquerque, 65-year-old David Mann is just going about another day's work when a man armed with a shotgun storms into his open garage. The gunman demands the keys to the company truck, but David strategically outsmarts and overpowers his attacker.

- ***Surprise Attack premieres Wednesday, September 23 at 9:30/8:30c***

Cody Munoz and Luisa Loy are out for an afternoon motorcycle ride when a driver stops behind them at a red light, and with no warning, gets out and punches Cody in the face. In the midst of it all, Cody maintains his composure, calmly asking the man why he is behaving so violently. The shocking road rage incident is captured on Cody's helmet camera and becomes a viral sensation, racking up over 16 million views. And then, Concepcion Escalante is finishing up a routine day at her family's insurance business when a man comes in with a knife, demanding money. When Concepcion refuses to hand over cash, the man attacks her, and she ends up in a desperate fight for her life.

## **IMPACT OF MURDER**

### **New Episodes Premiere Thursdays at 9/8c**

IMPACT OF MURDER utilizes the emotionally gripping victim's impact statement delivered in court as the driving storytelling technique. Through a victim's own words, viewers understand the horror they endured or the significance of the life that was taken, providing an acute understanding of the collateral damage of murder. Impact statements act as a source of strength for those who may feel helpless after a senseless tragedy, showcasing the empowerment that they feel when they stand up in court to address the perpetrator.

- **Stolen Dreams premieres Thursday, September 17 at 9/8c**

In Longmont, Colorado, a 911 dispatcher receives a call from a woman in distress. Seven-months pregnant, another woman has slashed her throat and she is clinging to life. But when police arrive, the woman they find covered in blood doesn't appear to be pregnant. Assuming that the victim somehow escaped and this is the perpetrator, they rush the woman to the hospital. Down the hall, doctors try to resuscitate the miscarried baby of a woman who arrived just minutes before. As the dispatcher uncovers the horrific event linking these two women, she forges a fast friendship with the victim, and paves the way for her to get justice.

- **The Betrayal premieres Thursday, September 24 at 9/8c**

In St. John's, Newfoundland, 19-year-old Greg Parsons ushers in 1991 by calling his mother Catherine. The two have a rocky relationship but had recently patched things up. He wants to wish her a happy new year. Two days later, Greg calls the police, crying that he has found his mother dead on the bathroom floor, and finds himself charged with her murder. His journey through the justice system will take years and become a national story.

### **SIGNS OF A PSYCHOPATH**

#### **New Episodes Premiere Sundays at 10:30/9:30c**

Charm. Narcissism. Lack of empathy. Impulsiveness. Manipulation. Deception. These traits and others are the telltale SIGNS OF A PSYCHOPATH. This harrowing half-hour archive series revisits some of the most dangerous killers in modern history, reviewing news footage—and the words of the killers themselves—to see which terrifying traits each killer exhibited.

- **I Dug a Hole and Said a Prayer premieres Sunday, September 20 at 10:30/9:30c**

When police question a man in the disappearance of his pregnant ex-girlfriend and her young son, they discover he has a terrifying capacity for violence. And later, could a seemingly innocuous man searching for a missing girl be a real-life monster?
