World Premiere Sunday, November 7 10 PM	Beauty Queen Killer Former beauty queen Darlene Gentry called 9-1-1 and told the dispatcher that her husband, Keith Gentry, was bleeding and making an awful gurgling sound. She went on to tell the dispatcher that she had noticed that the back door was open and several weapons were missing from the gun cabinet. Police found all but one of the guns that were reported missing. But, while searching the Gentrys' home, investigators discovered a pair of latex gloves

	<p>that contained Darlene’s DNA and other potential evidence pointing toward her involvement. Police arrested Darlene, but Keith Gentry’s parents believed she was innocent and bailed Darlene out of jail. Shortly after Darlene was released, she purchased some property. However, a tip a few weeks later resulted in the Texas Rangers searching Darlene’s property, where they found, at the bottom of the pond, the gun that was missing from Keith’s gun cabinet. The police set up a surveillance camera at the pond, and they videotaped Darlene wading into the shallow water and probing the bottom with a stick. The videotape of Darlene was used as a key piece of evidence at her trial where she was found guilty and sentenced to sixty years in prison. This episode of ON THE CASE features never-before-seen footage of investigators interviewing Darlene prior to her arrest.</p>
<p>World Premiere Sunday, November 14 10 PM</p>	<p>Gallaudet Murders At Gallaudet University, a prestigious school for the deaf and hard of hearing, Eric Franklin Plunkett was found dead on the floor of his dormitory. Police learned that Plunkett and his best friend, Thomas Minch, had engaged in a physical fight earlier that day. Minch was arrested, but released the next day because prosecutors cited insufficient evidence. Months passed and then fellow Gallaudet student Benjamin Varner was found dead on the floor of his dorm room. His checkbook had been stolen and investigators uncovered a forged check made out to Joseph Mesa that was cashed after Benjamin’s death. Joseph Mesa Jr. confessed to both murders and the never-before-seen interrogation footage is featured in this episode. Minch, after being a suspect for months, was finally cleared of any involvement. He shares his story for the first time with Paula Zahn. .</p>
<p>World Premiere Sunday, November 28 10 PM</p>	<p>Murder She Wrote: Ann Stout Case When Anne Stout found her husband, Bill, lying dead on their bed, police at first believed he committed suicide. After investigators examined the crime scene, they realized that the absence of a weapon near the body pointed them towards a homicide. Bill Stout’s ex-girlfriend, Barbara Miller, was the prime suspect. Investigators had heard from Bill’s family members about a wave of threatening emails Barbara had purportedly written. But when questioned by police, Barbara denied any involvement and claimed Anne had been threatening her. Investigators asked computer experts to analyze Anne’s computer and they reported that the threatening emails sent from Barbara to Bill had actually come from Anne’s computer. Investigators now believed that Anne had concocted an elaborate plan to kill her husband and frame his ex-girlfriend. Anne sits down for her first interview since being convicted and opens up to Paula Zahn about the events leading to her husband’s death.</p>

DISAPPEARED follows the unpredictable twists of missing person cases, tracking investigations aimed at solving how and why people simply vanish. While some of the resolutions are heartwarming and others tragic, many cases remain open to this day and continue to be a source of unbearable frustration for family members and friends. Each episode of **DISAPPEARED** begins from the time immediately before the individual vanished, searching for clues hidden beneath seemingly everyday behavior that may indicate whether or not the person left voluntarily. For the open cases that have gone cold, **DISAPPEARED** asks viewers to share fresh leads in hopes of deciphering what truly happened to the missing and whether foul play may have been involved, hoping to bring a sense of closure to their families.

<p>World Premiere Monday, November 1 10 PM</p>	<p>Lost Trust Elizabeth and John Calvert were living the good life, running their boating resort business, Harbour Town Yacht Basin, on Hilton Head Island. When Elizabeth notices a significant amount of money missing from the accounts, she contacts the businesses former accountant, Dennis Gerwing. He explains that the problem stemmed from a computer glitch and he would explain it to the Calverts if they would meet with him. Family and friends became worried when the couple began missing appointments the day after their meeting with Gerwing. The Sheriff's Office names Gerwing a person of interest in the Calverts case, but before investigators can gather enough evidence to arrest him, the case takes a horrifying turn for the worse. To this day friends and family are still left without any answers about what happened to Liz and John Calvert. <i>Loc: Hilton Head, SC</i></p>
<p>World Premiere Monday, November 8 10 PM</p>	<p>Lost Highway In the summer of 2009, 22-year-old Bradyn Fуска moved out of his parent's house to begin life on his own. But when Fuskas's parents suddenly stop hearing from their otherwise communicative son, they call the police. Things go from bad to worse when they also discover a handgun missing from their home and that Fуска's car was found abandoned seven hundred miles away in Wyoming. Fуска's family and friends feel their world turn upside down as police reveal that he has been guarding a dark secret – there's a warrant out for his arrest. But even as the pieces of this disturbing puzzle come together and it appears that Fуска is running from the law, he is still nowhere to be found. The Georgia Bureau of Investigation (GBI) immediately probes the abduction while over 17 law enforcement agencies launch a massive search. The GBI investigates a similar incident that occurred just nine days before Cornwell disappeared, and only 25 miles north. Eight months pass before agents are able to identify a suspect, however the man won't talk, leaving family and friends to worry if Kristi Cornwell will ever be found. <i>Loc: Blairsville, GA</i></p>
<p>World Premiere Monday, November 22 10 PM</p>	<p>Mojave Mystery After six months in the Mojave Desert recovering from the custody loss of her children, April Pitzer is ready to come clean and return home. She calls her mother, and relieved to have Pitzer back in her life, her mother begins making plans for her daughter's return. Just weeks later, Pitzer calls her</p>

	<p>mother and tells her that the past has caught up with her. With Pitzer's identity as an informant exposed in an area known for its methamphetamine trade, Pitzer fears for her life and knows she must leave. Yet when her mother sends for her just days later, she is nowhere to be found. Over the years, police and Pitzer's mother, Gloria, tirelessly pursue every rumor and every lead about her daughter, trying to fill in the missing pieces of the puzzle to where April Pitzer could be. <i>Loc: San Bernardino, CA</i></p>
<p>World Premiere Monday, November 29 10 PM</p>	<p>Unfinished Business When 45 year-old CFO John Glasgow leaves his home early on January 28, 2008 and never makes it to work, family and friends are immediately concerned. People begin to wonder whether troubles at work over the last several months are tied to his disappearance. Within 24 hours of Glasgow's disappearance, the family is led to the remote area where his cell phone was last turned on. Just hours later, employees at a nearby state park locate his SUV, sitting idly in the lot of a popular tourist lodge. But the car and its location tell investigators little about Glasgow's whereabouts, and the race to find the missing CFO ensues. <i>Loc: Little Rock, AR</i></p>

COLD BLOOD TV-14

New Episodes Premiere Tuesdays at 9 PM

COLD BLOOD returns to the crime scene so that viewers can examine all the evidence for themselves. Combining the thrill of mystery with the visceral experience of true crime drama, this series presents competing versions of what may have happened, and re-enacts the events from different perspectives as new evidence comes to light. Each episode tells the story of one homicide investigation that revolves around the forensic investigation of the crime scene, and follows the clues wherever they may lead.

<p>World Premiere Tuesday, November 2 9 PM</p>	<p>The Murder That Divided Boston While on their way to a Boston maternity class, a white suburban couple is carjacked and shot in a violent inner city neighborhood. On the verge of death, the man calls 911, and when police arrive on the scene, he describes their assailant as an African-American male in a jogging suit. The victims are taken to a hospital, and while the husband, Chuck Stuart, survives, his wife Carol and their unborn child do not. Exacerbating racial tensions in the city, the case generates significant media interest and investigators are under enormous pressure to find the culprit. No physical evidence was found in the car, but when police establish a hotline, hundreds of calls come in, and two possible suspects emerged. Did the crime stem from a drug deal gone wrong, or could there be a third suspect and a much darker motive for murder? <i>Loc: Boston, MA</i></p>
<p>World Premiere Tuesday, November 9 9 PM</p>	<p>Ties that Bind On a lonely stretch of an Illinois highway, an abandoned car ignites the search for 23-year-old Karyn Slover. Investigators search the vehicle for clues, her boyfriend makes an impassioned public plea, and her employer offers a \$10,000 reward for her safe return. But two days later, a local fisherman discovers Slover's body dismembered into a series of plastic bags. An autopsy later reveals she also suffered multiple gunshot wounds to the head. At first, police have two suspects, Slover's boyfriend and her ex-husband. But after two years and no new leads, the investigation reaches a dead end, forensic science is the last hope to try and crack this cold case. <i>Loc: Decatur, IL</i></p>
<p>World Premiere Tuesday, November 16 9 PM</p>	<p>Gainesville Ripper A deranged serial killer is on the loose in the college town of Gainesville, Florida. The first two victims are freshmen college roommates whose mutilated bodies are found posed in bizarre positions. The following day, another student is found decapitated. Then only a day later, the bodies of another two students are discovered in their apartment. A major</p>

	investigation kicks into action but evidence is scarce. When police close in on their prime suspect, they fail to establish a forensic link and the case goes cold. Investigators expand their search for the 'Gainesville Ripper' hoping to find their culprit before he strikes again. <i>Loc: Gainesville, FL</i>
World Premiere Tuesday, November 23 9 PM	Hollywood Homicide An aspiring society photographer from Switzerland is brutally murdered in his upscale Los Angeles home. When officers investigate, they find blood has dripped from the ceiling and down walls, shards of glass are everywhere, and the body of 37-year-old Roland Kuster lays facedown on the floor. Police first suspect this may be a case of a random robbery gone wrong, but as they learn details about Kuster's social life they begin to suspect the culprit is someone he knew. Investigators turn to forensic science to help find their murderer. <i>Loc: Los Angeles, CA</i>
World Premiere Tuesday, November 30 9 PM	Granny Killer In 1993, a community in Florida was hit by a string of violent crimes against seniors, and a massive investigation ensues. At first, the home of an 80-year-old widow goes up in flames. Then, an assailant seriously beats an elderly couple and sets fire to their living room. Another fire leaves a 72-year-old woman dead in her mobile home. With all signs pointing to a serial killer with a taste for elderly women and arson, local and state police join forces with the FBI. Although there are several suspects, investigators find little evidence among the ashes to build a case. <i>Loc: Spring Hill, FL</i>

I (ALMOST) GOT AWAY WITH IT TV-14

New Episodes Premiere Tuesdays at 10 PM

For these perpetrators, the stories may be different, but the motives are always the same – to stay out of prison and live life on the lam. The people profiled in **I (ALMOST) GOT AWAY WITH IT** evaded justice for years, sometimes decades, by using their families, fake identification and even violence to avoid capture. Viewers learn how law enforcement uses all means necessary to capture these fugitives. Additionally, each episode features an interview from prison with these slick culprits, who spill where they found shelter, how they changed their identities and how they almost got away with it.

World Premiere Tuesday, November 2 10 PM	Got to Roll the Dice Phillip Williams had 41 arrests on his record with no convictions. He apparently did not think that brutally stabbing his ex-girlfriend in a casino parking lot would give him much trouble. However, when he became a wanted man he got nervous and hit the road. With only the clothes on his back and the money in his pocket, Williams drove across the country in hopes of escaping the law.
